### Terms of payment

Payment for participation in the NSTT No-Dig Event can be requested by NSTT from the moment of signing this contract by both exhibitor and NSTT No-Dig Event.

The NSTT applies a payment term of 30 days.

From the moment of registration, all exhibitors will be included with their name / logo on the website of the NSTT No-Dig Event and in the Event newsletters.

### Cancellation

If the NSTT decides to cancel the NSTT No-Dig Event, each exhibitor will receive the amounts paid by it, minus € 125.

If an exhibitor decides not to participate in the NSTT No-Dig Event, the following scale applies:

- If participation is canceled before September 15<sup>th</sup>, 2021, € 125 will be charged to the exhibitor
- If participation is canceled on or September 15<sup>th</sup>, 2021 but before November 15<sup>th</sup>, 2021, 20% of the total amount will be charged to the exhibitor
- If participation is canceled on or after November 15<sup>th</sup>, 2021 but before January 15<sup>th</sup>, 2022, 50% of the total amount will be charged to the exhibitor
- If participation is canceled on or after January 15<sup>th</sup>, 2022 but before March 15<sup>th</sup>, 2022, 90% of the total amount will be charged to the exhibitor
- If participation is canceled on or after March 15<sup>th</sup>, 2022, 100% of the total amount will be charged to the exhibitor

The above amounts are offset against amounts already paid.
